This announcement is made by China Titans Energy Technology Group Co., Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap.571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company and potential investors that based on its preliminary assessment of the Group’s unaudited consolidated management accounts for the year ended 31 December 2024 (“**FY2024**”) and information currently available to the Board, it is expected that the Group would record a loss attributable to the shareholders of the Company in range of approximately RMB44 million to RMB47 million for FY2024 as compared to the loss attributable to the shareholders of the Company of approximately RMB43.979 million for the year ended 31 December 2023. The increase in expected loss for FY2024 is mainly due to, amongst others, (i) increase in administrative and other expenses; (ii) increase in selling and distribution expenses; and (iii) decrease in gross profit margin as a result of adjustment of overall sale strategies for increase in market share.

As at the date of this announcement, the Company is still in the process of finalizing its results for FY2024. The information contained in this announcement is only a preliminary assessment by the Board based on the unaudited consolidated management accounts of the Group and the information currently available to the Board, which has not been audited or reviewed by the Company's independent auditors or the audit committee of the Board and may be subject to adjustments. Details of the Group's annual results for FY2024 will be disclosed in the annual results announcement of the Company, which is expected to be published by the end of March 2025.
